When children feel safe and supported, they gain confidence to try new endeavours, learn, and grow. As a Christian school, we strive to provide Christ-based education, as the fundamental mission of what we do each day. It is my privilege to continue as part of this wonderful community of learners.

This year has marked another season of growth, with a continued increase in student enrolments as families seek a Christ-centred education that nurtures the whole child. We celebrate the many outstanding achievements of our students across academic, sporting, and creative pursuits, a testament to their hard work and the dedication of our staff.

We are also pleased to report meaningful progress in securing space for the school's future building project, which will allow us to meet the growing needs of our community while staying true to our mission.

Our school remains a safe, secure, and stable environment where students are supported to thrive. We are grateful for the leadership of Dr. Alese Plichta and Deputy Principal Netta Collins, and for the ongoing commitment of our exceptional teachers and staff. The positive involvement of families and the broader community continues to strengthen our school culture. We give thanks to God for His continued favour, provision, and guidance as we step forward in faith into all that He has planned for the next season.



Deputy Principal (Mrs Netta Collins)

2024 was another exceptional year for the school. The growth in enrolments and engagement with our families highlights the positive reputation of the school and the quality education framed in a community setting of the school. The school underwent its registration inspection with NESA and received excellent feedback on the programs and policies, providing registration renewal for the next five years.

Some high points of the year included the school musical, Let's Rock, which was performed to a capacity crowd and delighted response. We also celebrated the standout efforts of individual students in academic and sporting endeavours.

The teaching staff had a focus over the year on promoting a position of kindness amongst the students, and this was demonstrated through an increase in senior students looking for ways to assist teachers in the playground and finding ways to support junior students. It was also delightful to see students look for ways to raise money for Compassion, as they made items at home to sell to their peers at school. One of the biggest hits came from a Year 2 student, who made tubs of slime to sell.

During professional development, the teachers spent time increasing their understanding of the new English and Mathematics syllabus documents, engaging with new ways to teach these subject areas. The staff also reviewed strategies to support students who had undergone trauma, writing individual education programs, supporting students who speak English as an additional language and looked at ways to embed grammar into writing lessons.

Some favourite moments over the year include the opportunities to let the students dress up and have fun, while engaging with learning in a different way. The two literacy days for 2024 were themed around Superheros and Where's Wally. The students had a great time looking for Wally all over the school in a sea of red and white. Both book fairs also had excellent attendance from families, as they purchased over \$6000 in books this year. We also held a second "Walk Safely to School Day" event at the school, closing the carpark and setting up play equipment. Students were able to order a fruit cup or fruit and yoghurt cup for breakfast and parents and students spent time together enjoying the sunshine, physical activities and yummy food.

Our "Afternoon with the Teachers" event was a full house, particularly the behaviour management and helping students with homework sessions. We look forward to holding more of these events in the future. Parent feedback was very positive and many parents communicated about the usefulness of the sessions.

Overall, the school enjoyed a positively framed year, with staff, students and families connecting and building community in many different meaningful ways.



Coordinator's Report (Ms Asli Senel)

In 2024, our school community continued to embrace a holistic approach to learning that nurtures the academic, social, emotional, and spiritual growth of every student. As School Coordinator, I have overseen the development and implementation of programs in Literacy, Numeracy, and Wellbeing, with a strong focus on early intervention, parent partnerships, and inclusive practices.

We placed significant emphasis on strengthening early literacy through the explicit teaching of phonics and sight words, particularly in the early years in 2024. Daily review routines, decodable texts, small learning support groups and phonics-based assessment tools supported our literacy goals. We also worked closely with parents, learning support staff, and external professionals, including speech pathologists, occupational therapists, and psychologists, to provide early identification and intervention for students with literacy needs. Teachers received ongoing support in adjusting classroom practice to meet the learning profiles of students with specific needs.

A major area of focus has been improving the quality and effectiveness of Individual Education Plans. Staff participated in professional learning on writing individual goals for students, differentiation in lessons, and collaborative goal setting with families and health professionals. As a result, IEPs are now more personalised, measurable and better aligned with curriculum outcomes. Parent engagement in the planning process has also increased significantly, fostering stronger partnerships and shared responsibility.

In Numeracy, we continued to encourage students to develop conceptual understanding through the use of hands-on materials, open-ended questions, and visible thinking strategies. Teachers prioritised mathematical fluency and reasoning while differentiating tasks to cater for diverse learners. Data from our Numeracy Continuum and classroom assessments assisted us with ongoing planning and small group interventions.

Student wellbeing remained a key priority in 2024. We supported students' emotional regulation through the continued implementation of the Highway Heroes program and built in creative and movement-based outlets during the school week. These included:

- Lunch Clubs (e.g., Art, Dance, Chess) to promote student interests and friendships,
- A school Talent Show in term 3, encouraging confidence and celebration of individual gifts,
- Coordination of the Sporting Schools Football Program, which promoted fitness, teamwork, and positive sporting behaviours, and
- Our Whole School Musical, which united students across K-6 in a creative, collaborative experience.

In 2025, we will continue to review our current school goals based on student data and needs and further upskill staff in inclusive and trauma-informed teaching. We will meet and create a partnership with the Western Sydney Local Health District through participation in the Live Life Well @ School program.



Staff Representative Report

2024 has brought new experiences and memorable moments to Westmead Christian Grammar School. We have represented our school in the broader community in many activities and wonderful achievements.

Madhav Menon joined our school in 2024, and his swimming prowess took him to CIS which enabled him to participate in representing our school at the State and National level. Madhav achieved 1st at the CIS competition in the 200m Individual Medley and placed 3rd in the 200m butterfly. Many students watched the race live and proudly cheered on their classmate. Well done Madhav!

In 2024 we were fortunate enough to hold two book fairs. Students and staff enjoyed dressing up and participating in our parade showcasing their creativity with our Superhero and Where's Wally themes. Students thoroughly enjoyed solving their grade's word jumble and the school wide scavenger hunt. All proceeds from our book fair have allowed us to build extensive class libraries with texts of different genres and student interest encouraging them to access a wide collection of quality literature in their classroom. We have also been fortunate to increase our collection of quality decodable readers for the classroom and home readers.

Our Athletics Carnival also proved to be an exciting day for Westmead Christian Grammar School with students from Kindergarten to Year 6 participating in various activities throughout the day. We were able to send five students to the CSSA State Athletics carnival, and all participants proudly represented their school with enthusiasm. Additionally, students participated in the State Cross Country carnival highlighting their determination to give their best in representing their school.

Our "Meet the teacher" evening was a successful night with many parents in attendance. Our teachers provided information and support to parents in understanding the core ideas for Literacy learning, behaviour management and accessing and utilising local public libraries to encourage their child to develop a love of reading. A big success of the evening was the "Healthy Food" choice presentation. Parents and students in attendance were shown many ways to make healthier choices for the lunchbox and many tips and recipes continue to be posted regularly on Dojo.

Excursions and Incursions

During 2024, the students enjoyed a range of excursions and incursions, as well as celebrating a range of events at school. Some of the year's highlights included Harmony Day and Walk Safely to School Day. These events created an opportunity to see the diversity of our community and to promote a healthy lifestyle.

Years One and Two travelled to the city and participated in sessions at the Big Dig site, learning about Australian History and how archaeologists learn about the past. They also spent the day exploring the Royal Botanic Gardens in Sydney, building knowledge about Aboriginal Australian farming techniques and history. Years 3-6 visited Auburn Botanic Gardens with the goal of learning about native and exotic flora in Australia.

A highlight for the year was the camp to Canberra for students in Years 4-6. They visited a range of sites, including the Australian War Memorial, Parliament House, the Australian Mint and Government House.



Other incursions included a visit from the Environmentors and Golden Ridge Animal Farm. The school enjoyed two Book Fairs, a Science Day, Clean Up Australia Day, Big Veggie Crunch, Crazy Hair Day and Pyjama Day.

The Cross Country, Swimming and Athletics Carnivals were all very well attended and provided opportunities for the students to extend opportunities to excel in sport.

Learning and Teaching

Westmead Christian Grammar School is committed to providing quality Christ-centred education through learning and teaching. All NESA requirements are being met as the school seeks to implement best practice of meeting the needs of all students enrolled. In addition to the Key Learning Areas prescribed by NESA, the students are provided with Christian Education through Devotions, Bible lessons and a weekly Chapel service.

Assessment and Reporting

Teachers continued to dialogue about assessment and reporting, striving to develop consistent judgment for transparency about student outcomes for parents. Reports align to the NSW version of the Australian Curriculum outcome statements and indicators of relevant syllabus requirements. Formal reporting was completed twice through the year at the half yearly and yearly mark.


Catering for Individuals



Sports Report

2024 has seen WCGS continue to develop in sport and sporting achievements and offer opportunities for students from across the school in a variety of events. Students participated in a range of planned sporting sessions. The past

STAFFING

Staff Population

All of the teaching staff of Westmead Christian Grammar School met the Professional requirements for teaching in NSW schools. During 2024, we had 12 New Scheme Teachers, with 4 staff members working towards accreditation. One staff member was accredited during 2024. All staff were category (i) teachers and had access to entitlements such as sick leave. Three staff members accessed maternity leave during the year. In 2024, the average daily rate of staff attendance was 95.02%. Staff included Principal, Deputy Principal, Business Manager, Coordinators, 11 full time teachers, a part time Chaplain, and Support Staff. The qualifications of teaching staff include:


STUDENT POPULATION

POLICIES

ENROLMENT POLICY

The successful enrolment of students at Westmead Christian Grammar School is an essential part of the ongoing management of the school. This policy provides the guidelines for enrolment into the school. The Enrolment Policy and its implementation will control to a large degree the culture of the school community, most evident in the Christian ethos, leadership, atmosphere, and beliefs which form the basis for the implicit curriculum, as well as shaping the explicit content, skills, values and attitudes. Westmead Christian Grammar School believes that an effective Enrolment Policy is required to ensure that the mission of the school and service is maintained and promoted through all day-to-day decisions and operations. To enrol a student at the school or in the Preparatory or Out of Hours School Care (OHSC) Services, parents must be prepared to support Christian Education. To this end all students and their parents, must agree to support the Christian ethos through participation in all educational programs.

The Principal is responsible for overseeing and approving the selection and enrolment of all students, however the School Board of Directors hold ultimate responsibility for determining the Enrolment Policy. Upon receipt of an official application form and prior to enrolment, all prospective families endeavouring to enrol a student shall be interviewed by the Deputy Principal. In the case of students with special needs, or wherever deemed appropriate, the prospective student may also be seen by one of the teachers who will make recommendations for the enrolment selection, school readiness and class determination. Prior to enrolment, all educational needs should be considered to ensure that Westmead Christian Grammar School can offer the program required for the student (Conditions of Enrolment can be found at wcgs.nsw.edu.au).

ANTI-HARASSMENT STATEMENT

Westmead Christian Grammar School is committed to ensuring the health, safety and welfare of all members of our school community. It is the desire of the school to have all members of the community working together without threatening others and without feeling threatened. It is believed that every member of the school community is deserving of tolerance, respect and acceptance. One way this is achieved is through the Anti-Bullying Policy.

ATTENDANCE POLICY

Westmead Christian Grammar School is committed to optimising student access to education by ensuring that regular attendance by all students is maximised. All students who are enrolled at Westmead Christian Grammar School, are expected to attend school whenever instruction is provided. To this end, an outline for attendance will be available and will be in accordance with the Education Act (1990). Staff will be trained in the importance of attendance and the management of the attendance requirements of the school. Parents will be encouraged upon enrolment and whenever an issue of attendance is identified, regarding the joint responsibility between the school and the home, to ensure that students have regular attendance at school whilst they are within school age. It is understood that it is through the accurate maintenance of school rolls that attendance is monitored. This is for the safety and wellbeing of students and is an important official obligation of the school.

The Legislative framework for this policy is the Education Act (1990). The other related policies and guidelines include the Registration System and Member Non-Government School (NSW) Manual (NESA), and the Westmead Christian Grammar School Child Protection Policy.

SAFE AND SUPPORTIVE ENVIRONMENT (WHS) POLICY

Westmead Christian Grammar School is committed to ensuring the health, safety and welfare of all members of our school community. We are committed to progressively implementing the requirements of the Work Health and Safety Act 2011, Work Health and Safety Regulations 2011 and Work Health and Safety Codes of Practice while adhering to the Explosives Act 2003.

DISCIPLINE POLICY

Westmead Christian Grammar School is committed to providing behaviour management through encouragement of positive behaviour, consistent monitoring and addressing negative choices, towards encouraging individual growth for all members of the school community. In accordance with Government legislation, Westmead Christian Grammar School does not use corporal punishment as part of its student discipline policy nor does the school explicitly or implicitly sanction the administering of corporal punishment by non-school personas, including parents, to enforce discipline at the school. Westmead Christian Grammar School is committed to providing a safe, caring environment for all its members. Discipline is one tool used in order to train students in accordance with the motto: to grow in wisdom and stature and in favour with God and man (Luke 2:52). God disciplines those He loves (Hebrews 12:5-11). He gives authority and the responsibility of discipline to the leaders of Government, the church and parents (Romans 13:1-7; Matthew 17:15-17; Proverbs 1:8; Proverb 23:13; Ephesians 6:4). At the time of enrolment parents agree that their child be taught according to the policies of the school. This does not remove any responsibility from the parents to discipline their child.

Discipline should always be for the benefit of the child. It should not be a negative concept and does not merely consist of punishment for wrongdoing. Westmead Christian Grammar School is committed to fostering moral skills, in the differentiation of right from wrong. Discipline should be based on love and aligned with the principles of God's Word. Teachers are encouraged where possible to use positive reinforcements to ascertain the correct behaviour from students wherever appropriate rather than initiating disciplinary action. Discipline within Westmead Christian Grammar School is based on a 'whole school' approach. Consistency is a vital component of the success of this policy. The school size enables all staff to get to know the students of each stage. When a violation of the behaviour standards occurs the form of discipline necessary is determined by the nature of the misconduct. Consequences should:

- Be appropriate in terms of severity,
- Be consistent in application (mindful of special circumstances),
- Address any harm done (restitution where appropriate), and
- Facilitate the restoration of positive relationships between offender and offended.

GRIEVANCE POLICY

Westmead Christian Grammar School is committed to providing an environment, which promotes the health and wellbeing of all members of the school community. It is recognised that from time-to-time there will be occasions when issues arise between members of the community, i.e. staff, students, parents and the wider community. The Complaints, Appeals and Grievance Policy seeks to ensure that complaints arising from situations of conflict and disharmony among members of the school community are addressed in a fair and transparent manner to bring a favourable resolution. Parents, students and staff members have a right to raise concerns, questions or bring complaints, in relation to behaviour, practices, decisions or individuals, and to expect these matters to be addressed appropriately with objectivity and sensitivity. Westmead Christian Grammar School, as part of its obligation in relation to its duty of care to students and staff members, strives for procedural fairness and natural justice for all. Our school is committed to maintaining its bond of biblical community. Disharmony within the school community is intended to be resolved through employing biblical principles and due process.

COMMUNITY SATISFACTION

COMMUNITY INVOLVEMENT AND SATISFACTION

This year the students were highly motivated to continue to raise money for Compassion. They ran a range of stalls at lunchtimes, selling home made items to raise money. This initiative inspired junior students to participate with giving up their own resources and time to support the project. The students also participated in a Crazy Hair Day and Pyjama Day to raise additional funds. Compassion supports children in need all over the world.

The School was invited by Cumberland Council, for a second time, to run a booth at their Easter festival. This opportunity to meet the local community was well supported by both staff and students, with the WCGS booth having many families return from the previous year.

We have seen an increase in Class Dojo use by our families to above 90% reading rate on posts, and 98% of families now connected through the platform. Parents have communicated about the convenience of use and the new class chat feature has been accessed by most of the Infants parents to facilitate the answering of quick questions.

The information sessions for parents held in Term One was attended by more than a third of the school's community, showing a high level of engagement from parents with the school. Feedback from the sessions revealed that parents were looking for additional ways to support their children's learning at home and the school responded by providing additional material on strategies for supporting literacy and numeracy.




